the law should change big time people who dont want to be under the state trustees they want to get it they should let them go

there is alot of clients are the same as me they get less then me.

i have kids to think about case managers which i have should be supportering me not against me and the other thing is that they want to sell my mums house there is alot of work to be done.

falling apart and they say i dont have money to fix it but they want me to go for rentals.

they are all, pushing me and its got to stop, i am most of the time stressed because of the state trustees.

my mum mentioned in the will × and me and my kids.

but state trustees saying now i dont have any benefits to the house we have a life intrest in the property for free but my brother lives in a disability home they say they need to sell the property my mother was under state trustees as well.

no one is helping they are just thinking of themselves thats not right people will be accountable to god for it

vcac is just the same as state trustees and other companys like them and i had an administor who was 24 years and telling me what to do

it my money not theres but now i have alot of and they want to sell and put it in trust for them and thats not what the will says

the law needs changes people are getting depression because of them as well.

if they cant fix the house they should get another one for me somewhere else cause i ain't moving and mum before she died was so worried about me where i was going to live because state trustees tryed for 7 years to get rid of us so they can get there greedy money on it.

they arent going to kick me and kids out i am staying where i am they want me to go to comission housing or rentals i could not get it they say try harder no more trying harder i cant afford it.

and the other thing is that i was a carer for my mother before she went into the nursing home my mum worked very hard for her money and state trustees wants to take it no no no.
